Expanding Respiratory Protection Programs for Long Term Care Facilities and other Congregate Settings in New York City

Project Overview

The New York City Department of Health and Mental Hygiene, Office of Emergency Preparedness and Response (NYC DOHMH OEPR) invites you to participate in an exciting, new opportunity to enhance NYC's preparedness for infectious diseases by expanding respiratory protection capabilities at long-term care facilities (LTCFs). The Expanding Respiratory Protection Programs (RPPs) for LTCFs and other Congregate Settings in NYC will be led by TRC Environmental Corporation contracted to provide the below services to participating facilities. Facilities who participate in this program will receive support for the development and maintenance of their respiratory protection programs and will enhance their staff's and resident's safety for communicable diseases transmission

This program is expected to be operational from March 2023 to June 2024.

Program Activities

Needs Assessment and RPP Training Plans

The vendor will perform RPP needs assessments at selected LTCFs and other congregate settings volunteered to participate in this program. Based upon the needs assessments, the training will provide facility staff with essential knowledge and tools better protect themselves and their patients from infectious diseases, by helping facilities to operate safely.

Respiratory Protection Program Consultations

Upon request by a participating facility, the vendor will perform **at least one consultation per facility** about respiratory protection needs. This consultation will provide an opportunity for facilities to get expert advice on how to enhance their respiratory protections.

Mobile Fit-Testing Services

The vendor will offer mobile fit-testing services onsite to all NYC LTCFs, once a year.

Fit-Testing Train-the-Trainer Sessions

Train at least one staff member from each participating facility on how to perform qualitative fit-testing services for their facility. Staff who participate in Train-the-Trainer sessions will be given a fit-testing kit and extra supplies to allow fit-testing staff at their own facilities. Trainings will be done at locations in the 5 boroughs.

Free procurement of equipment

The program is able to procure for free up to 60 days supplies of certain brands and models of N95s respirators. Additionally, the vendor will be able to provide for free air purifiers, HEPA filter replacements, surgical masks, KN95s and COVID-19 antigen tests.

How to Participate

Participation in the program is voluntary but full participation is encourage to enhance your respiratory protections.
