New York State Department of Health (NYSDOH) Emergency Preparedness and Life Safety Technical Assistance Workshop

The NYSDOH Office of Primary Care and Health Systems Management (OPCHSM) and the Office of Health Emergency Preparedness (OHEP), with the assistance of their colleagues at the Continuing Care Leadership Coalition (CCLC), the Greater New York Health Care Facilities Association (GNYHCFA), the Healthcare Association of New York State (HANYS), Leading Age, New York (LANY), and the New York State Health Facilities Association (NYSHFA), have developed a workshop curriculum to assist nursing homes in the development and practice of emergency preparedness planning and response, as well as provide updated information regarding certificate of need requests and life safety code, needed to protect their residents, staff and assets during, and following emergency situations.

There are two parts to the workshop program, each covering unique, though related content. See detailed description of each Part of the program below. *

Part One: Emergency Preparedness -- will be led by OPCHSM and OHEP emergency preparedness and response staff to assist providers and provide technical training and information regarding existing tools and resources that support the following four, fundamental elements of emergency preparedness, required of nursing homes in the **CMS Final Rule for Emergency Preparedness, implemented in 2017:**

- **Risk Assessment and Emergency Planning** "all hazards," emergency response planning to identify all risks to safe operations the facility, and its community are most likely to experience and a *delineation of necessary facility response activities*.
- Policies and Procedures development and implementation of policies and procedures that support the successful execution of the emergency plan based on identified risks
- Communications Plan -- development and maintenance of an emergency preparedness communication plan that complies with both federal and state law, and helps assure: continuity of resident care, and resilience of communication modalities with facility staff, resident families, and with state and local public health departments and emergency management agencies.
- Training and Testing -- development and maintenance of an ongoing emergency preparedness training and testing program such that staff can maintain and demonstrate knowledge of emergency procedures; conducting drills and exercises to identify gaps and areas for improvement, in the EP plan and staff competency.

Part Two: Update on Life Safety Code, Fire Code and Certificate of Need Requests -- will be led by NYSDOH OPCHSM Center for Healthcare Facility Planning, Licensure and Finance, Bureau of Architecture, Engineering and Review (BAER) experts and will provide a comprehensive discussion of current regulatory conditions for long term care facilities, including comparison of the 2000 and 2012 Life Safety Code-as well as updated Design Submission Guidance (DSG) and Certificate of Need (CON) submission requirements and Fire Safety.

Program Details: These workshops are given at *no charge* to providers. We ask that a limit of 1-2 of your staff attend as we expect a large response and wish to assure each venue can accommodate all facilities that wish to attend.

* Six venues in various regions of the State are planned, with additional venues being considered. Five of the workshops will be day long (9am – 3:30 pm) and will include both Part One and Part Two sections of the program. The workshop being given on 10/26/2017 in NYC is a half-day program; only Part One will be presented on that day. However, a recording of the entire workshop, including both Part One and Part Two, will be made available online.

Lunch will be provided at the full-day programs. Kosher selections will be made available. No food or beverage will be provided at the half-day sessions

Background

The NYSDOH Office of Primary Care and Health Systems Management (OPCHSM) and the Office of Health Emergency Preparedness (OHEP), with sponsorship of their colleagues at New York State Long Term Care associations*, are delivering a technical assistance workshop covering Emergency Preparedness (EP) and Life Safety Code (LSC). The workshop will provide training, discuss ongoing preparedness activities and resources already available to nursing homes that can help facilities be prepared for disasters and be compliant with new regulatory requirements put forth by the Centers for Medicaid and Medicare Services (CMS) for EP and LSC.

- updated information regarding certificate of need requests, life safety code, needed to protect nursing home residents, staff and assets during, and following emergency situations
- clarification of new regulatory requirements for nursing homes and survey elements






