Changes to the Pre-Admission Screening Process for Transitional Adult Homes

January 2022

Goal of Today's Training

- Department of Health (Department) regulations at 18 NYCRR §487.4(e) establish a preadmissions process for Transitional Adult Homes (TAHs).
- The process requires screening of prospective residents to determine whether they may be a person with serious mental illness (SMI). Depending on the screening results, a mental health evaluation may be required.
- The Department has arranged for Kepro to conduct the screening and the evaluations.
- Kepro will explain the process for TAHs to request screening and evaluations, and how results will be communicated.

Preadmission Screening (Current)

- Prior to any admission to a TAH, the operator must contact the Department to request a pre-admission screening by sending the prospective resident's name, date of birth, guardianship information, and Medicaid identification number.
- Currently, the screening request and the prospective resident's information is sent directly to the Department via the Community Transition Upload tool on the Health Commerce System.
- If the prospective resident is not enrolled in Medicaid, the TAH must indicate whether the pre-admission interview and/or medical evaluation suggest a need for a mental health evaluation (MHE).
- The Department provides a response within three business days of receiving a complete request.

Preadmission Screening (Future)

- Going forward, TAHs will contact Kepro to request screening and submit the prospective resident's name, date of birth, guardianship information, and Medicaid identification number.
- The TAH will submit a *PSYCKES Consent Form*, which will be made available by the Department and must be signed by the prospective resident.
- If the prospective resident is not enrolled in Medicaid, the TAH will submit copies of the written summary of the admission interview and the medical evaluation, along with an *Authorization for Release of Health Information (DOH 5032)*.
- Kepro will provide a response within three business days of receiving a complete request.



Goals of the Revised Process

- Streamlined pre-admission process.
- Consistency of evaluations to benefit the resident/prospective resident.
- Consistency of records to benefit the TAH.
 - Better QSIR data.
 - Easier to provide records at survey.

Screening Results: Information Needed

- Lack of Medicaid Information
 - Currently, the Department contacts the TAH and ask if the pre-admission interview and/or medical evaluation suggest a need for an MHE.
 - Going forward, Kepro will handle this outreach, and the TAH should submit a completed *Authorization for Release of Health Information (DOH 5032)*.
 - Kepro will determine whether an MHE is warranted.

Screening Results: No Indication of SMI

- If the screening does not indicate that the prospective resident may be a person with SMI, the Department communicates that the TAH may admit the resident if all other admission criteria are met.
 - Going forward, Kepro will handle this communication.

Screening Results: SMI Indication

- If the pre-admission screening indicates the prospective resident may be a person with SMI, the individual cannot be admitted unless:
 - An MHE concludes that the individual is not a person with SMI; or
 - An MHE concludes the prospective resident is a person with SMI, but the individual is a former TAH resident and the operator obtains a waiver from the Department permitting the individual's admission.
- Currently, TAHs arrange for MHEs to be conducted using the *Adult Care Facility Mental Health Evaluation Form (DOH-5075)*.
 - Going forward, to pursue admission when a MHE is required, TAHs must contact Kepro.

Requesting a Mental Health Evaluation

- When requesting that Kepro conduct an MHE, the TAH will submit:
 - The summary of the resident interview;
 - The medical evaluation; and
 - A completed *Authorization for Release of Health Information (DOH 5032)*.
- TAHs may provide additional information they believe will help Kepro in conducting the MHE (for example, information from a treating provider).

Results of the Mental Health Evaluation

- Kepro will report to the TAH that the result of the MHE is:
 - The individual is not a person with SMI, in which case the individual can be admitted without an approved waiver; or
 - The individual is a person with SMI and cannot be admitted absent an approved waiver.
- Kepro will provide a copy of the completed MHE to the TAH.
- A TAH would use the completed evaluation if it wanted to apply for a waiver for a former TAH resident.
- A TAH may also use the evaluation to help identify and meet the needs of those individuals who are appropriately admitted.

Consent Forms

- The Department will share copies of the two consent forms, pre-filled as much as possible: the *PSYCKES Consent Form* and the *Authorization for Release of Health Information (DOH 5032)*.
- When requesting screening, the TAH must provide a completed copy of the *PSYCKES Consent Form*.
- The *Authorization for Release of Health Information (DOH 5032)* will be submitted at the time of a screening request, if the prospective resident is not enrolled in Medicaid or lacks sufficient Medicaid history, or at the point of requesting the MHE.
- TAHs must provide a copy of the signed consents to the prospective residents.

Waiver Reminder

- The request must be complete, signed, and on the correct form.
- The request must be for a former resident of a TAH requesting admission to a TAH, with all pre-admission requirements met.
- The request must be approved pre-admission, or the TAH may face enforcement.

Introduction

What is Changing as of February 1st?

Requirements for Preadmission Screenings and Mental Health Evaluations have not changed. Transitional Adult Homes will continue to follow all state regulations regarding the admission process.

NYS-DOH will continue with:

- All oversight of the preadmission screening and mental health evaluation process

On behalf of the NYS-DOH, Kepro will be completing:

- Preadmission Screenings
- Mental Health Evaluations

Transitional Adult Homes:

- Will now submit Preadmission Screening requests directly to Kepro
- Will no longer complete their own Mental Health Evaluations on prospective residents and will now submit MH Evaluation requests directly to Kepro

Admission Requirements

Transitional Adult Homes must comply with Title 18 NYCRR 487 Standards for Adult Homes.

TAH staff will contact Kepro to obtain a pre-admission screening to determine whether the prospective resident may be a person with serious mental illness, as defined in Title 18 NYCRR 487.2.

If the prospective resident is found to possibly have SMI, the TAH will contact Kepro to complete a face-to-face mental health evaluation if admission remains the goal.

Admission Requirements

Kepro is providing a system to facilitate an efficient assessment process. The provider portal is easy to use and has multiple advantages, but it is not required.

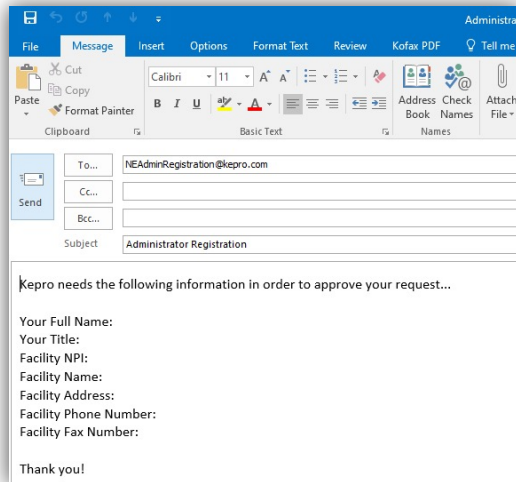

- Facilities only need to be registered one time. The person chosen to register the facility will be the account administrator. This will be the first person to log into the provider portal under the TAH facility account.
- You will need to designate a Provider Administrator for your facility. This person will need to add and manage all other users of the Provider Portal.

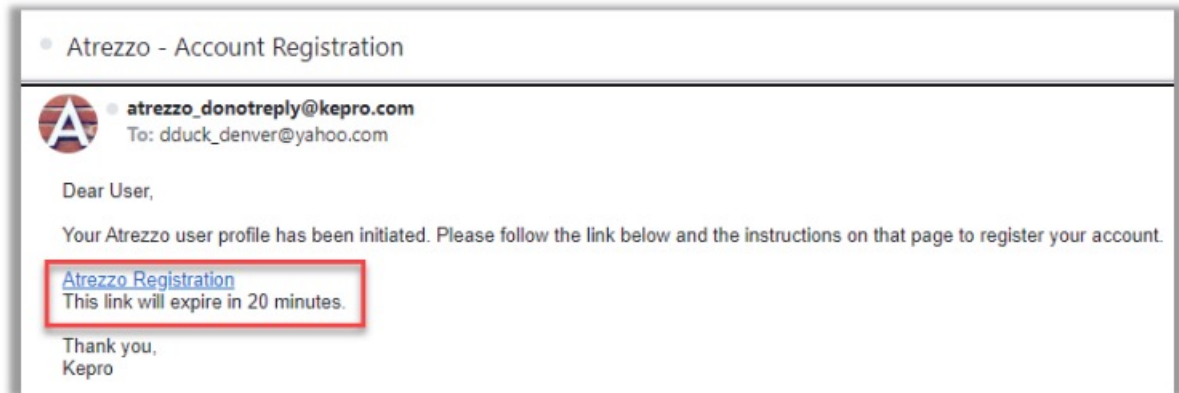

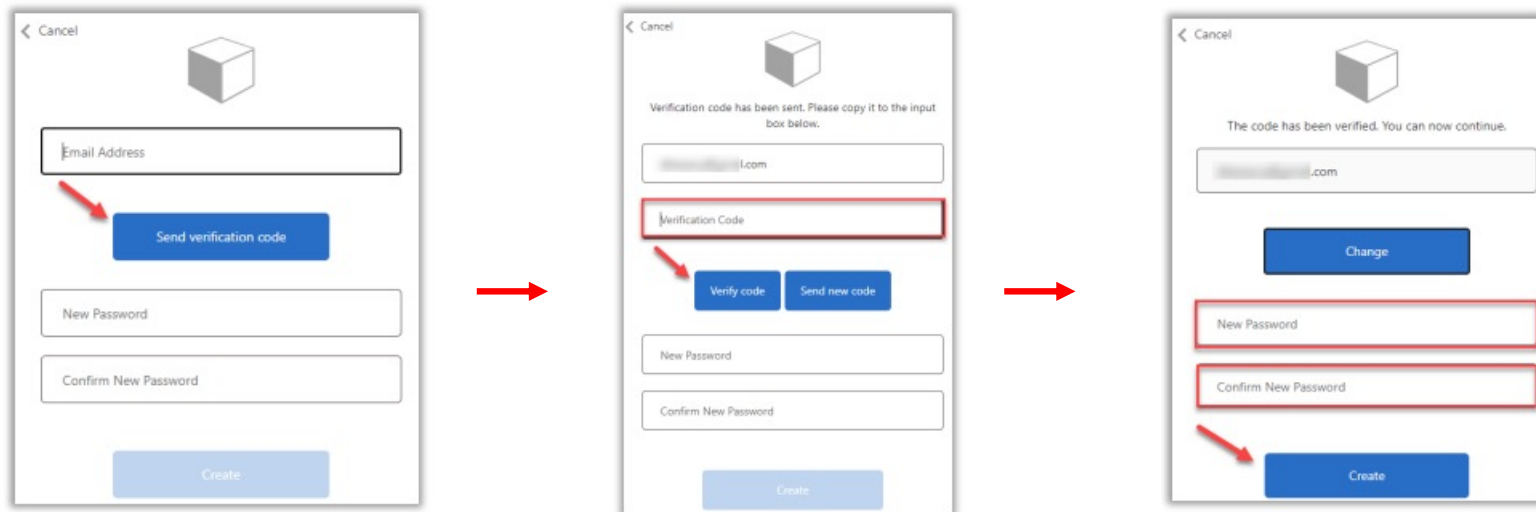
To complete the Multi-Factor Authentication registration, you must click the link in your email **within 20 minutes**.

Need to Deactivate, Update, or Change a Role for a User?

- You can create as many other users and admins as needed to help you to manage your facility account.

Two Types of User Roles

There are two types of user roles:

1. **Provider Staff Account** - this role can request assessments and view/print documents
2. **Admin Account** - this role can request assessments, view/print documents, and create new users, change user roles, or deactivate users.

What to Know?

- To request a preadmission screening or MH evaluation click **CREATE CASE** from the top navigation pane. Case Type is always Assessment and Case Parameters are always NY PAAH.
- Search for the consumer using last name and date of birth.
- If the correct consumer match is found, you can click on the button left of **SELECT MEMBER** and click **NEXT** to proceed with the case.
- If a consumer match is not found, you will be able to add the consumer to the system by clicking on **+ ADD TEMPORARY CONSUMER**

Helpful Hints

- Enter the full last name when you search.
- If you do not find the person in your facility account, you will add them to the system.

- It is best to add a person's **current location** in the address section unless unknown.
- Selecting “**Use Facility Address**” will populate the address information to match your facility and should only be used if the current location or mailing address is unknown.
- All fields with a red asterisk are required.

- Please always add their **Medicaid ID Number**.
- When finished, click on **Next** to load the consumer information and then click on **Create Case**

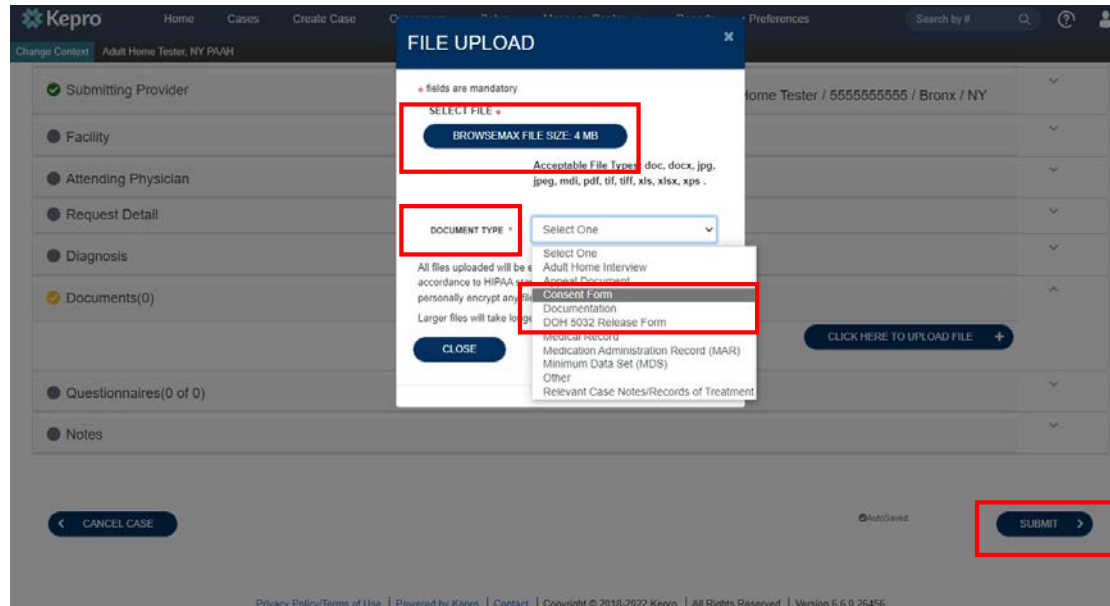

Preadmission Screening

- Kepro will access the New York State Office of Mental Health Psychiatric Services and Clinical Enhancement System (PSYCKES) to review all information on the individual's Medicaid behavioral health services. This requires that we have a copy of the consent form on file.
- Make sure to send the **consent** form or we cannot start the case.
- Documents can be uploaded, emailed to us at TAH_Assessments@kepro.com, or faxed to us at 718-816-3560.
- Preadmission screenings will be completed within **3 business days** of the request.

Prescreen Outcomes

Detailed information regarding the determination will be found in the notification letter.

Possible Outcomes:

- Meets SMI Criteria - **Cannot Admit without Evaluation**
- Does Not Meet SMI Criteria - **Can Admit**
- Unable to Determine - **Not Enough Medicaid Information** (cannot admit without an evaluation)

Screening was not completed. Will Need a Screening prior to Admission:

- **Administrative Closure** due to Case Withdrawn, Discharged Elsewhere, or Incomplete Referral.

Mental Health Evaluation

- Kepro will complete a face-to-face evaluation once all required documentation has been received.
- Make sure to send the following documentation to avoid an administrative closure:
 - **Authorization for Release of Health Information (DOH-5032)**
 - **Completed OMH PSYCKES Consent Form (completed with initial screening request)**
- To be submitted with the initial screening request when there is not enough Medicaid history, or when a mental health evaluation is requested:
 - **Medical Evaluation (including a medication list)**
 - **Summary of Interview by Adult Home**
- Additional supporting documentation that will assist the evaluator in completing the evaluation may be submitted with the request for a mental health evaluation (accompanied by appropriate consent forms). Examples are:
 - **Minimum Data Set (MDS), if residing in a nursing facility**
 - **Treatment Notes from a behavioral health provider**
- Documents can be uploaded, emailed to us at TAH_Assessments@kepro.com, or faxed to us at 718-816-3560.
- MH Evaluations will be completed within **7 business days** of the request.

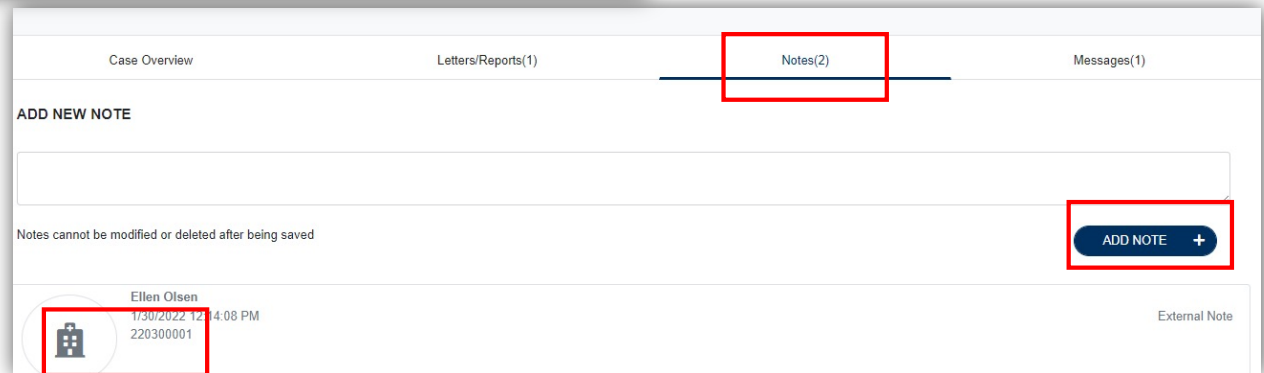
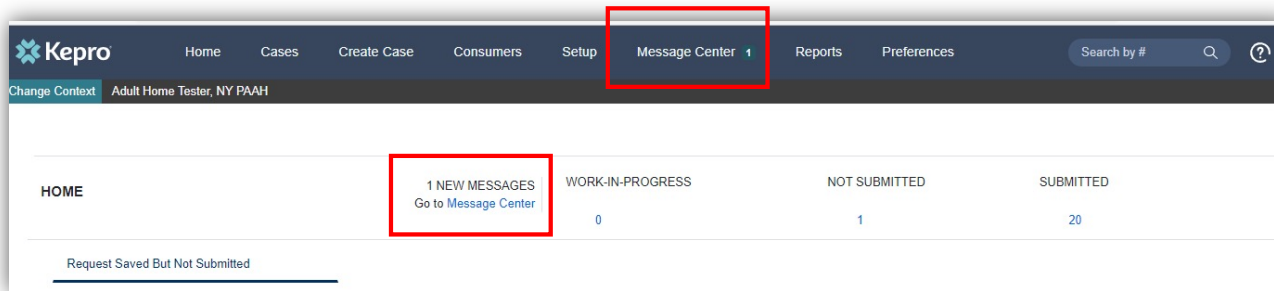
