



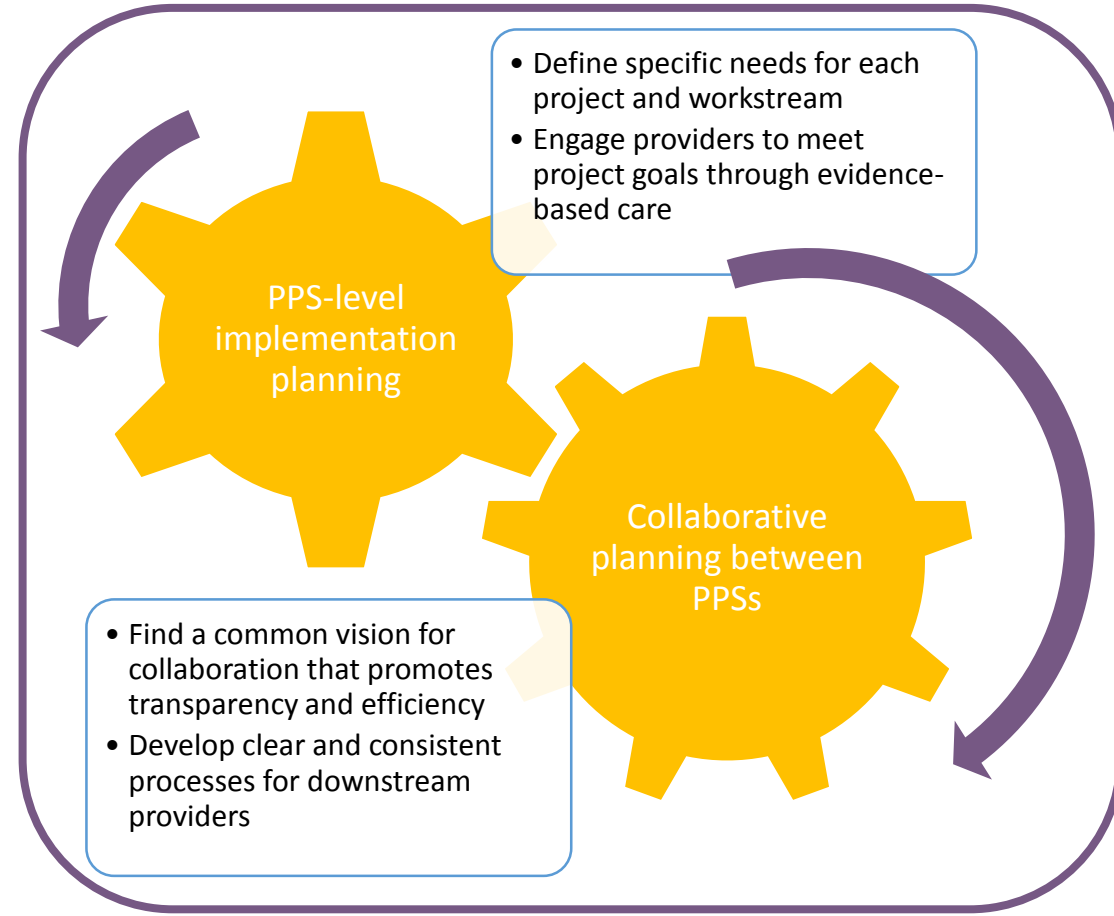
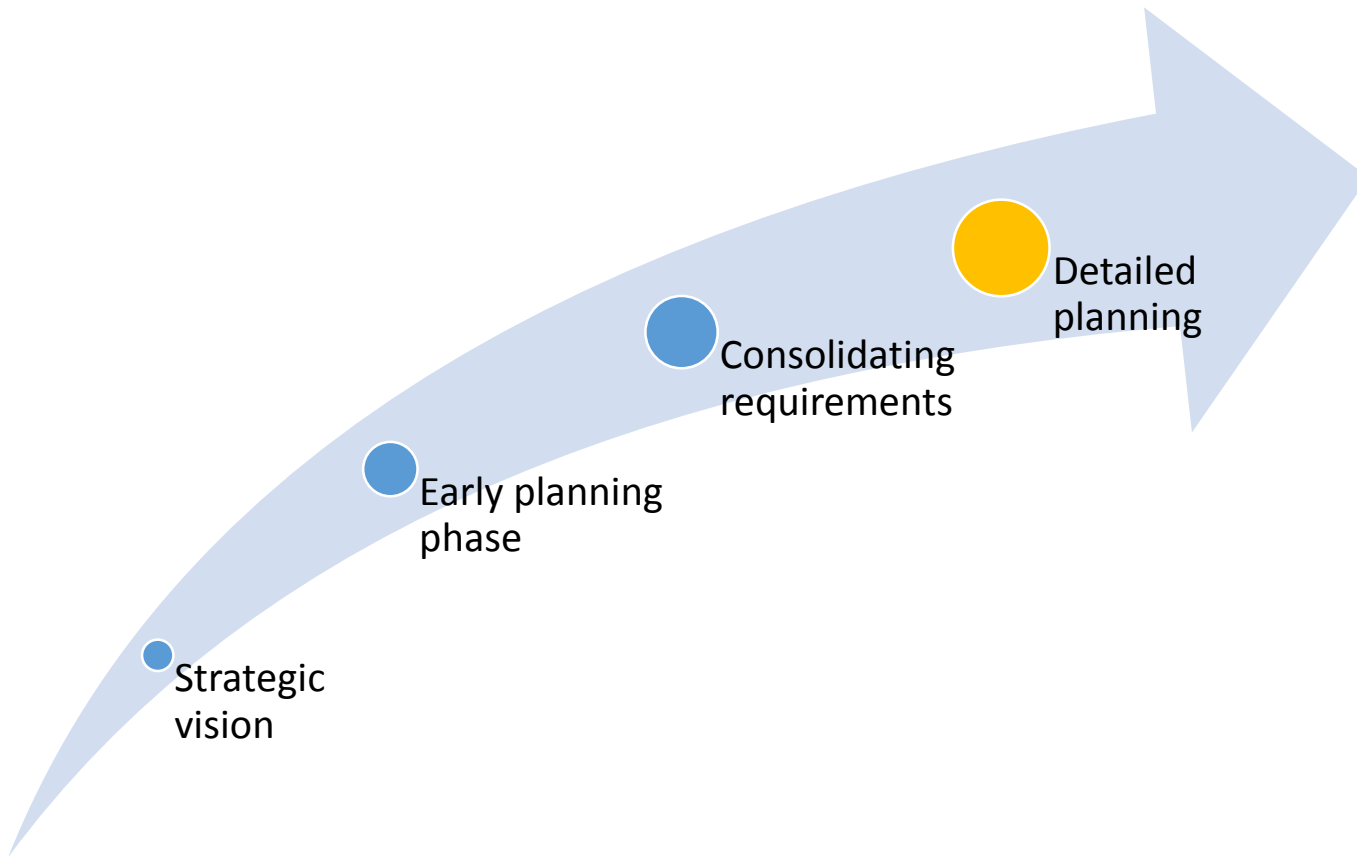

- The PPS chose 11 different projects

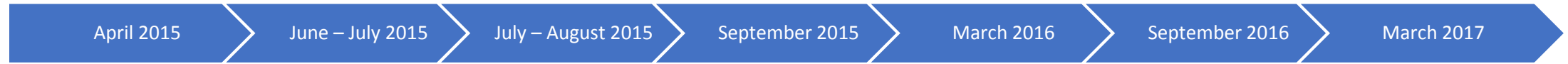

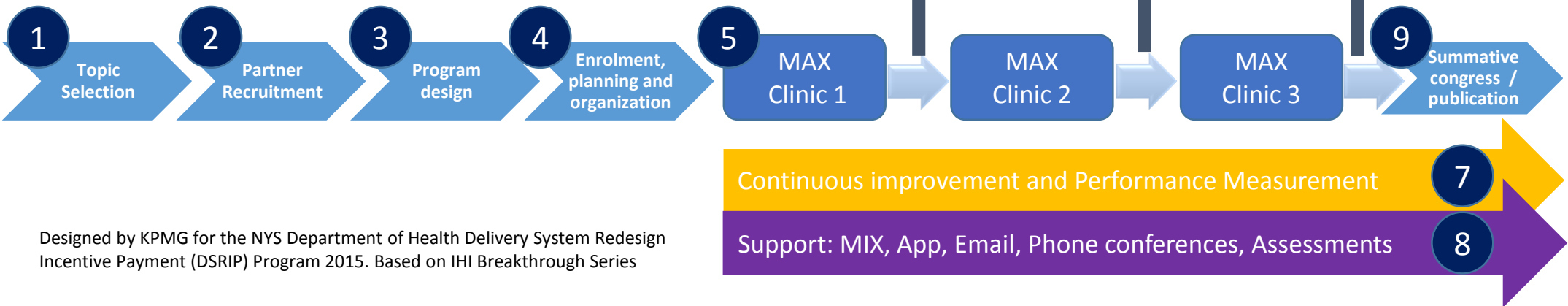
