The budget agreement also includes the elimination of bed-hold payments for facilities that do not enroll 50% of their residents eligible to participate in a Medicare managed care plan in such a plan and a global cap on Medicaid spending that confers on the Department of Health and the Division of the Budget the authority to make further Medicaid reductions if it is determined that spending is trending higher than established targets. It is not possible to accurately apportion the impacts of these two provisions to individual homes at this time although they may have considerable fiscal impacts.
