Dear Administrator,

The New York State Department of Health (NYSDOH) is committed to improving the efficiency and uniformity of Medicaid billing practices across the state. As part of this effort, we will be preparing to implement a change in the billing process for Nursing Home Transition and Diversion (NHTD) & Traumatic Brain Injury (TBI) Waiver providers.

This update is necessary to align with the Centers for Medicare and Medicaid Services' (CMS) waiver billing requirements which stipulate that claims must be billed to the locator based on the county in which services were provided; currently claims are billed to the locator based on the participant's county of fiscal responsibility. This change will also standardize billing locator codes/counties for all NHTD and TBI Waiver providers statewide and change NHTD Home and Community Support Services (HCSS) provider billing from one rate code for all HCSS regions to one rate code for each HCSS region; five in total, to align with TBI HCSS billing.

Providers will not yet be able to bill to these new county locator codes. The tentative effective date is July 1, 2025. Once all provider rate codes have been successfully transitioned to the new county locator codes in eMedNY we will send out new billing guidance and instructions as well as schedule a webinar.

We will transition the rates by RRDC region and as we do each NHTD and TBI provider will receive autogenerated system letters. Providers should carefully review these letters to confirm that the correct rate codes have been loaded to the correct county locator codes (attached) per your approved NHTD or TBI application.

The five new NHTD HCSS rate codes that you should be confirming you receive based on your approved service counties (in lieu of 9795) are:

9744	NHTDWVR HCSS-NYC REGION-HOURLY (Bronx, Brooklyn/Kings, NY/Manhattan, Queens, Richmond/Staten Island)
9745	NHTDWVR HCSS-LONG ISLAND/WESTCHESTER REGION-HOURLY (Nassau, Suffolk, Westchester)
9746	NHTDWVR HCSS-ROCKLAND REGION-HOURLY
9747	NHTDWVR HCSS-REST OF STATE REGION-HOURLY
9748	NHTDWVR HCSS-RURAL REGION-HOURLY (Allegany, Clinton, Delaware, Essex, Franklin, Hamilton, St Lawrence)
